#### A. Walnut Woods Pond

Executive Director Kathy Nowicki reported that the Park District is one of six members of the Walnut Woods Homeowner's Association. There are issues with the quality of the pond. The Homeowner's Association addressed this issue and found that the pond would benefit from a pond restoration. An alternate technique to mechanical dredging involves vacuuming the pond muck and storing it in permeable bags that would be stored on a flat surface along the property. There was discussion about this proposed project. The Board commented that they were unable to make a decision at this time due to the limited information that was provided. There were concerns about liability issues. Commissioner Malouf suggested for the Grounds Superintendent Jerry Arden to be involved and review the plans. The Board recommended for the Homeowner's Association to obtain a contract. The Board will review the contract and decide at that time whether or not the Park District will participate in this project. Commissioner Gollberg would be interested in see a location that has this alternate technique currently on the property.
