Executive Director – as submitted. Executive Director Christina Ferraro reported NRC held a meeting with the community. Christina distributed an email received from a resident who was in attendance at that NRC meeting. Christina had a discussion with Agnes of NRC related to the 2020 Budget. The resurfacing would be completed this year and the striping of the court would be completed next year. Staff would send out letters to the residents residing near Claire Lane Park and ask them if they have a preference of a tennis court or a Pickleball court.

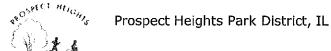

Room #2

Gym

North window in the gym facing the rear was leaking, since window is above rear hallway it's difficult to reach, caulk was used to seal the window where it meets the frame.

Rear patio

Since the sprinkler is now working on the rear patio, plants on the perimeter are filling in by the fence on the west and north side.

Security

Room One

Re: Investment proposal

BACKGROUND

Accounts at Mt. Prospect State Bank include:

- General- Balance as of Aug 31, 2019 \$1,112,904. Interest Rate of .03%.
 All deposits are received via the General Accounts. Funds are used to support operations via the Vendor, Payroll Accounts and Imprest accounts.
- Cash Reserves- Balance as of Aug 31, 2019 \$353,104.36 Interest Rate of .40%. Monies set aside, with limited activity.
- Investment- Balance as of Aug 5, 2019 \$3,049,574. Interest Rate of .80% (recently increased). Periodically 'excess funds' are transferred from the General Account. Monies are used to support capital projects and maintain fund balance.

Funds in excess of \$250,000 are protected through the collateralization agreement with MSB and Bank of America.

With the deposits on hand all banking fees are waived. This is significant, fees are charged per: deposit, check, ACH, wire transfers, monthly maintenance and online banking access.

RECOMMENDATION

Staff is proposing to convert the Cash Reserve to a CD 12 month or longer. As point of reference: as of September 9, 2019:14 month CD rate 2.00%

Through the budgeting process, staff will evaluate the District's short and long term cash flow needs and move monies from the Investment account to CD's, using a laddered approach to ensure necessary cash flow.

Re: Check signing authority procedure

BACKGROUND

Prospect Heights Park District business office has internal controls regarding signing checks. Currently, the procedure requires two signatures for all checks processed through the Vendor account. The signers on the account include several board members and the Executive Director.

RECOMMENDATION

Staff is proposing the Superintendent of Finance be added as a signer on the Vendor account and permitted to have the authority to sign checks less than \$2,500.

The procedure will continue to require two signatures but both the Superintendent of Finance and Executive Director are authorized to sign check up to \$2,500.

The Executive Director and a board member continue to be authorized to sign checks greater than \$2,500.

In an emergency situation, with the approval of the Board President (written or verbal) the Executive Director and Superintendent of Finance have authority to sign checks greater than \$2,500.

BACKGROUND

One of the Prospect Heights Park District bank accounts is an Imprest account which is a cash account used to pay for small, routine expenses. A \$5,000 fixed balance is maintained in the account, and it is replenished routinely through a vendor check to maintain that balance. The account has been used as a bridge between petty cash and vendor checks. One staff person and the Executive Director are authorized to sign these checks.

RECOMMENDATION

Staff is proposing the elimination of the Imprest account and transfer its current balance to the general account. Pending approval of the updated check signing authority procedure allowing the Executive Director and the Superintendent of Finance to sign checks less than \$2,500, there will be no need for the Imprest Account. Small reimbursement will be made through petty cash, anything larger will be included in with vendor checks.
